

FERTILIZER SUPPLY OFFER

2024 - 2025



1. Basic Arrangements

This document sets out the terms of an offer by Summit Fertilizers to supply you with fertilizer between 1st August 2024 and 31st July 2025. (2024–2025 Fertilizer Supply Season). To accept this offer and receive the benefits outlined below please complete a “Contract Form” (available on request) and return it to your local Area Manager or Agent.

Two supply options are available, and these are set out below.

Variable Fertilizer Supply Offer:

The list price that applies to this offer is the “Summit List Price” (as that term is defined in the Summit Fertilizers General Terms and Conditions of Sale that is in place on the date you collect the fertilizer, not the price at the date the offer is signed. The price payable by you on the date when you collect the fertilizer is the Summit List Price, less any price variations that you are entitled to upon acceptance of this offer and any other discounts applied at the discretion of Summit.

A Variable Fertilizer Supply Offer is available up to 31st October 2024, unless this offer is extended at Summit’s discretion.

Fixed Fertilizer Supply Contract:

If you choose a Fixed Fertilizer Supply Contract, the product, price, quantity, depot, month of collection and payment method are all fixed at the date the contract is signed.

There is no flexibility to change product, price, quantity, depot or month of collection.

A Fixed Fertilizer Supply Contract can be entered into at any time during the Fertilizer Supply Season 2024-2025 period but is dependent on Summit Fertilizers having product available.

Product must be collected by the end of the nominated collection month. Late collection will incur a \$10 per tonne per month storage fee.

To qualify for “Early Signing Benefits” (as further detailed below) a Variable or Fixed Fertilizer Supply Contract must be signed by the 31st October 2024, or such later date as Summit determines in its discretion.

2. Early Signing Benefits

If you sign a Variable Fertilizer Supply Offer or a Fixed Fertilizer Supply Contract before 31st October 2024, or such later date as Summit determines in its discretion, you will be eligible to receive a rebate of \$2.00 per tonne to be used for Summit Technical Services and Productivity Packages purchased during the 2024–2025 Fertilizer Supply Season.

You will also be granted priority access to depot supplies and to Area Manager services.

3. Method of Payment

BPAY

Pay by BPAY through your online banking option. Summit’s BPAY biller code is 220145.

Electronic Funds Transfers

Visa or MasterCard for an additional fee of up to 1.0% excl GST.

Cheques made out to “Summit Fertilizers”.

Fast Pay

Direct debit by Summit 3 business days after collection. Summit credit approval is required.

Quick Pay

Direct debit by Summit 7 to 10 business days after collection. Summit credit approval is required.

Pay 7

Direct Debit by Summit on the 7th day of the month following collection. Summit credit approval is required.

Pay 25

Direct Debit by Summit on the 25th day of the month following collection. Summit credit approval is required.

Deferred Harvest Terms subject to Summit credit approval. Fees will apply.

For Fixed Fertilizer Supply Contracts, the Method of Payment variations are considered at the time of the contract.

4. General Conditions

This Fertilizer Supply Offer is subject to Summit Fertilizers’ General Terms and Conditions of Sale.

This Fertilizer Supply Offer is not open to resellers or buying groups.

Summit Fertilizers reserves the right to withdraw or amend this offer at any time prior to acceptance.
