

# JUNE 30 2025 OFFER TERMS AND CONDITIONS



## Offer 1 – Pay Now Collect Later

1. For product purchased (ordered and paid for) before 26<sup>th</sup> June 2025.
2. Product in this offer must be collected from Summit storage from 1<sup>st</sup> July 2025 and not after 12 months from the date of invoice.
3. Product nominated in Offer 1 must be collected from Summit storage before the same product can be collected under any other Summit 2025/2026 Fertilizer Contract or offer.
4. Product which has not been collected by the dates stated in paragraph 2 above will be returned to Summit's stock and monies paid for that product in June 2025 will not be refunded.
5. The offer is available on most of Summit's product range, although some products may be restricted on first come first served basis due to limited quantities. Summit will advise customers at the time of ordering whether product restrictions apply to the product requested.
6. The sales contract is on a fixed supply basis irrespective of whether international prices move up or down during the 2025/2026 season. In all other respects the sales contract is subject to Summit's General Terms and Conditions of Sale (refer: [www.summitfertz.com.au/pdf/general-terms-and-conditions-of-sale](http://www.summitfertz.com.au/pdf/general-terms-and-conditions-of-sale)).
7. If the customer chooses a 10% deposit option as payment, then the 10% deposit must be paid prior to 26<sup>th</sup> June 2025. The sum payable will be 10% of the total invoice value including GST. The outstanding balance will be due and payable no later than 25<sup>th</sup> January 2026, or on collection if prior to this date.
8. Orders will be confirmed if payment is made by 26<sup>th</sup> June 2025.
9. Product is invoiced before 30<sup>th</sup> June 2025 and as such is owned by the customer and held in storage by Summit.
10. No product changes or refunds are available after 30<sup>th</sup> June 2025 and product must be collected before the dates outlined in paragraph 2 above.
11. No other discount offers can be used in conjunction with this offer.
12. This offer is not open to resellers or buying groups.
13. The purchase price includes product insurance up until the product has been collected from Summit storage.
14. The 2024/2025 Fertilizer Supply Offer Terms and Conditions (refer: [www.summitfertz.com.au/pdf/fertilizer-supply-offer-2024-2025](http://www.summitfertz.com.au/pdf/fertilizer-supply-offer-2024-2025)) also apply to any orders placed under this offer. These Offer Terms and Conditions will prevail to the extent of any inconsistency.

## Offer 2 – Pre-Pay Now Nominate Later

1. Pre-pay a lump sum amount into your Summit Fertilizers account before the 26<sup>th</sup> of June 2025, up to a maximum amount of AUD\$1.5 million plus GST, per Summit Fertilizers account. The pre-payment will be invoiced as “EOFY 2025 Pre-paid Fertilizer” prior to 30<sup>th</sup> June 2025.
2. Pre-paid funds must be paid in full. No deposit options are available under Offer 2 – Pre-Pay Now Nominate Later.
3. No cash refunds will be available. Funds will be held in your Summit Fertilizers account and must be used for fertilizer purchases only. Any funds remaining 12 months after the invoice date of prepayment amount will be forfeited.
4. Pre-paid funds can only be used for collections between 1<sup>st</sup> August 2025 and 12 months after the date of invoice.
5. Monies paid to Summit as a part of this 2025 Pre-Pay Now Nominate Later offer will qualify for a reward as set out below. The reward amount is not interest.
6. Customers will be entitled to receive a reward amount calculated daily at an annual percentage rate of 5.0% on the funds that are held in your Summit Fertilizer account at that time during the period 1<sup>st</sup> July 2025, until 25<sup>th</sup> February 2026.
7. The reward is calculated on a daily basis on the balance of the pre-paid funds only and will be credited to your Summit Fertilizers account prior to 31 March 2026.
8. Reward amounts are not redeemable for cash and must be used for the purchase of fertilizer from Summit. Any reward amount remaining 12 months after the invoice date of prepayment will be forfeited.
9. The pre-paid funds cannot be used against invoices issued by Summit prior to the pre-payment. Payment of invoices issued prior to this Pre-Pay Now Nominate Later offer are not subject to the offer and are not eligible for a reward.
10. Fertilizer nominated must be contracted in the 2025/2026 “Summit Fertilizer Supply Offer” under either a Variable or Fixed Fertilizer Supply Contract.
